<b>Agreement between Parent/Legal Guardian and Rickmansworth Archery Club</b>
---

**If Parents/Legal Guardians of secondary school aged children/young persons do not wish to remain with their child/young person during the Club's archery sessions, they must agree this in advance with the Rickmansworth Archery Chairman, Coaching Leader or Child Protection Officer and agree to the following conditions:**

- I agree to remain with our child/young person until the Club archery session commences and in the event that insufficient supervisory personnel are available, understand that the session will be cancelled.
- I accept that it is my/our responsibility to collect my/our child/young person at the times requested.
- I accept that it is my/our responsibility to inform the Club of any special medication/condition, allergy and/or use of medical equipment which may be needed by my/our child/young person during archery sessions.
- I consent to first aid treatment being given by a qualified First Aid person to my/our child/young person in the event of an accident.
- I consent to my child/young person being photographed by a club official for the purposes of promoting Rickmansworth Archery Club, and understand that this will exclude the disclosure of any personal details.
- I acknowledge that if my/our child/young person enters any Archery Tournament, I will attend that tournament with my child and be responsible for his/her care.
- I understand that all archers including children/young people are eligible for drug testing if requested at any domestic tournament.
- I understand that my/our child/young person has to abide by the Club's Shooting Etiquette, Constitution, Disciplinary Procedure and Child Protection Policy all of which can be found on [www.rickmanswortharchery.club](http://www.rickmanswortharchery.club) under "Membership"
- I understand that the Archery Insurance cover for my/our child/young person is only valid for shooting at recognised Archery Clubs affiliated to Archery GB and any shooting my/our child/young person does elsewhere will be at my/our own risk and for my/our own personal liability
- I declare that my/our child/young person will only use wooden, carbon/aluminium or aluminium arrows when shooting outdoors but that s/he may shoot carbon arrows if/when s/he shoots indoors. S/he will not shoot any other types of arrows.
